Portsmouth's air quality is among the worst in the UK, with pollution levels in continuous breach of both legal limits specified in the EU Air Quality Directive, English law and World Health Organisation (WHO) guidelines. The Let Pompey Breathe campaign calls for stronger action to tackle the problem, including releasing an Air Quality Action Plan for consultation as soon as possible.

In February 2018 the High Court ruled the Government's plans to reduce air pollution are inadequate and unlawful. The Court explained that the Department for Environment, Food and Rural Affairs (Defra) 2017 Air Quality Plan does not contain sufficient measures for 33 local authority areas to ensure substantive compliance with the Article 13 of Directive 2008/50/EC and Regulation 26 of the English Regulations (the Air Quality Standards Regulations 2010 (2010/1001)). Portsmouth is the most polluted of those 33 local authorities. The Environment, Food and Rural Affairs select committee has called on Defra to take stronger measures and clarify its guidance.¹ Defra has set a deadline of 31 July 2018 for councils to produce an action plan.²
